Motion to accept Minutes (Beth) from Wednesday October 27, 2010 – Seconded (Ang). Passed.

Registration:

All rosters approved a distributed. May still be a few more APs?

Financial Report: Need approximately \$4000.00 to cover the 5 sets of jerseys that do not have sponsors.

Reminder that all purchases of any equipment MUST go through Darryl Verbeek. Submitting receipts after the purchase has been made is not acceptable.

OMHA:

Time Keepers/Game Sheets: Timekeeper to write name and phone number on the white sheet only. If the timekeeper has miscoded a penalty it is up to the coach to clarify so that the player sits the appropriate amount of time. Let Beth know so she can follow up with Michele. The refs should catch this as well but ultimately it is up to the coach.

Match Penalties: The ref will always write a separate report for Michele regarding match penalties. Once she receives this info she will give us the number of games that the player sits out. Until this is finalized please write 1of ?, 2 of ?... if you get to 3 you should really be following up. Michele has 14 days to get the number to us but to expedite this we can fax her a photocopy of both sides of the white game sheet with a note indicating that the ref will be sending the original but this will get things going.

Suspensions: Automatic Suspensions CANNOT be appealed. If a player gets a penalty and the wrong number is written on the game sheet the coach needs to correct this and make sure that the right player sits out.

Injury Report: These are now done online. Have the Trainer print of a copy for Beth as well. If medical attention is required you must still fill out a Hockey Canada Report and give Beth a copy so she can mail it to Michelle.

Refs: Please do not allow coaches/player/parents/grandparents... to talk to the refs following a game. This is not acceptable behavior and never has been.

Rep Trophies: Beth still needs them (Peewee and Atom) back ASAP

Registration: First year players only require birth certificates to register.

Trainers: Refresh can now be done online... won't include any materials. First time Trainers must still attend course.

Play Offs: Any team wanting to move up for playoffs need to let Beth know by next meeting.

OMHA Directive on Rough Play: Letter to be posted in all arenas outlining the OMHA policy and expectations around players remaining in control and practicing self-discipline. Beth will contact managers and ask that they have their teams and families read it.

Local League:

Game Sheets: Please be sure that both teams and timekeepers are pressing hard when writing on the gamesheets. Tanya is having trouble reading them because they are so light.

Equipment: There are 2 sets of Tyke Jerseys and 3 sets of Midget Jerseys that need sponsors.

Fundraising:

Attack Game: No up date at this time from Regina.

Fundraising Policy: Discussed that when a team is doing individual team fundraising that they bring their proposal to the Executive and that we look at each situation case by case. All funds would go through the organization regardless of the situation.

We drew the cash draw tickets for November.

Risk Management: All police checks must be complete by December 31.

If you do not have a police check you will not be on the bench for playoffs.

New Business:

Tyke Pucks: Tykes/Mites should be using the blue pucks for games unless both teams agree to use the black.

There are blue pucks at the back at the arena.
